We target to have modern slavery due diligence within our global supply chain. To this end, Suppliers are requested to provide details of their own practices and their supply chain in relation to modern slavery.

We are committed to ensure that there are no practices that promote or encourage modern slavery or human trafficking in our supply chains or in any part of our business

DUE DILIGENCE PROCESSES FOR SLAVERY AND HUMAN TRAFFICKING

We ensure that:

- Our employees follows the code of conduct, which sets out our commitment in ensuring that we all act and are treated ethically, fairly and with respect and dignity. We recognize that our employees' continuing success as individuals, colleagues and as a company depends on all of us treating each other with respect and upholding the highest professional and ethical standards.
- Prior to engaging employees, workers or contractors we try to ensure that they have NI, Social security or other statutorily recognized unique identification numbers (as applicable in the country of employment) and that they are eligible to work in the countries in which they are working and/or residing;

We have in place systems to Identify and assess potential risk areas in our supply chains in order to:

- Mitigate the risk of slavery and human trafficking occurring in our supply chains;
- Help employees understand how they should report suspected instances of modern slavery and child trafficking;
- Due diligence and review processes for our supplier onboarding procedures.

TRAINING

To ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and our business. We have referred to our people the website modernslavery.co.uk to provide them with useful information on modern slavery and human trafficking, how to recognise the different types and how to report it along with details of a helpline. We are in the process of developing a training module to create awareness on modern slavery and human trafficking with our employees who manage the supply chain.
